INSURANCE

Tennis Victoria's Personal Accident Insurance Membership cover is designed to offer players some peace of mind by having insurance protection for certain costs related to an injury sustained whilst playing tennis in a sanctioned event, particularly Loss of Income and Non Medicare Medical Expenses.

If you are a Registered Player of a Tennis Victoria Affiliated Club, and have been registered with Tennis Victoria, you are automatically covered by Personal Accident Insurance. This benefit is designed to reimburse players for certain out of pocket expenses as a result of sustaining an injury, whilst playing tennis.

NUNAWADING TENNIS CLUB GENERAL RULES

As a member of Nunawading Tennis Club you have assumed responsibilities immediately on admittance to the club. You will find you have office-bearers who generously give their time and energy so that you can play and enjoy the game. Appreciate the efforts they make on your behalf.

Do your part to enhance the reputation of your club, encourage new members to join, assist at events organised for the good of the club and offer your help if you can; don't wait to be asked.

The cost of maintaining the club is ever exercising the thoughts of your committee. Without stable and sufficient finance, no club can be successful. You are earnestly entreated to generously accept your portion of the financial responsibilities and support any revenue raising activities.

Court Care

Correct tennis footwear **MUST** be worn at ALL times. The wearing of ripple soles, joggers or dress shoes will not be permitted under any circumstances because of the damage they do to the courts.

Courts must be bagged, fence to fence and, as required, watered before commencement of play. In dry weather, lightly sprinkle the courts before bagging to keep the dust down and inconvenience players on other courts to a minimum.

Use the sponge rollers to dry wet courts and after use, empty the rollers in drains and return to their holders beside courts 1, 5 or 6. Courts must not be used in severe frost conditions.

Clubhouse Care

The clubhouse must be cleaned after competition play, day and night, by the duty team for that day. This includes vacuuming the carpet (vacuum cleaner in ladies change room), sweeping the steps, and cleaning the kitchen area. All crockery used must be washed, dried and put away.

Ensure all chairs are returned to the clubhouse and all exterior gates are locked.

In general terms, leave the clubhouse in the condition in which you would like to find it when you next visit the club.

Visitors

Members are entitled to bring visitors to the courts, but they must pay a visitor's fee. For adults, this is \$6.00 per person per attendance and for juniors \$3.00. Fees should be given to:

- A committee members
- Put in the honesty box by the telephone.

The husband/wife of a member is considered a visitor and a fee must be paid.

Court Hire

The courts are available to people who are not guests of members. They must however arrange the hire of the courts through Helena Sheehan (9894-3040) and pay the following fees:

- Day hire - \$15.00 per hour per court
- Night hire - \$27.00 per hour per court
- Members night hire - \$10.00 per hour per court (if bringing guests, a visitor's fee for each of these guests must also be paid.)

Members are entitled to use the courts at all times other than when competition, tournaments or coaching are in progress. Any courts not occupied and not closed, during these activities, are available to members.

General Demeanour

Members are required to treat their fellow members and their guests with proper respect and courtesy. Bad language, displays of ill-temper, verbal abuse and all other forms of foul behaviour on the courts, or within the club's premises, will not be tolerated.

It is also a condition of using the Nunawading Tennis Club premises that members of visiting teams abide by the same rules as laid out for our members in this category "General Demeanour". Any complaints in this regard should be brought to the attention of the Secretary.
